The delay in finalization of Disciplinary cases is prime concern since long. The CVC, New Delhi is time and again impress upon the concerned authority for timely completion of Disciplinary Proceedings /Inquiry in the respective organization. In this connection the CVC/ DoPT as well as our MoS have issued guide line regarding prescribed time frame to be adhered by various Disciplinary Authorities. Accordingly, the CVO, DPT has also referred the all guidelines and instructions issued by CVC, Ministry very oftenly as referred.


In spite of clear guide line and directions from the various authority like CVC, DoPT, MoS the time frame suggested are not adhered certain Disciplinary Proceedings and found pending for much longer time it is also imperative to bring to the notice Of all the Disciplinary Authority that the delay in completion of Disciplinary Proceedings for undue and unexplained reasons may also cause un-necessary & avoidable litigation. The Hon'ble Supreme Court of India has also noticed such undue abnormal delay which attracted adverse comment of the Hon'ble Apex Court and recorded in its judgement.

Therefore in order to comply the standard/prescribed time limit of six months and to ensure prompt timely action in Disciplinary matter the CVC has again Impress upon all the Disciplinary Authority of the organization for strict adherence in the organization. The Circular No. 18/12/20 dtd 14.12.20 issued by CVC in the subject matter is also enclosed for ready reference and record to enable all the Disciplinary Authority for adhering to the prescribed time limit and to avoid delay in finalization in Disciplinary cases.

All the Disciplinary Authorities are therefore advice to refer the above guidelines and instructions in the subject matter and ensure to comply the same in its true spirit.
