**Section-I**

**SCOPE OF WORK**

**TERMS AND CONDITIONS**

- (1) Deendayal Port Authority intends to carry out the work of '*Minor overhauling of 02 nos. Diesel Engines available at Oil Jetty no. 1 & 2, Deendayal Port*'.
- (2) Work shall be guaranteed against the manufacturing defects for six months from the commissioning date (after successful trial and testing).
- (3) No transportation, accommodation shall be provided by DPA.
- (4) Payment terms:
  - All payments shall be made in Indian Rupees through RTGS / NEFT, for which the contractor is required to furnish the details as required by DPA.
  - 90 % payment towards work shall be released after successful trial & commissioning in presence of Third Party Inspection (TPI) Agency (to be appointed by DPA) and receipt of bills in triplicate through RTGS.
  - 10 % of the contract value will be retained and it will be released after successful completion of total guarantee / warranty period.
- (5) The contractor is encouraged to inspect the site to understand the actual requirement and better clarification of work (at his own cost).
- (6) The completion period for said work will be within 45 days from the date of issuance of Work Order.
- (7) Party will be responsible for the poor workmanship or manufacturing defect during the guaranteed period. During the guarantee period, any part (s) is required to be changed due to poor workmanship of the contractor or manufacturing defect, the cost of spare parts will be borne by party & re-work and other auxiliary work including trial is to be done by the contractor at free of cost. In this connection, decision of Engineer In Charge will be final and binding to the party.
- (8) Rate offered by the contractor and accepted by DPA will remain constant till successful completion of the work.

- (9) Party has to arrange all required tools & tackles, instruments and any other required consumables mobile equipments for lifting and shifting of materials, labour manpower etc. to perform / supply the requisite work.
- (10) In case of delay in completing the contract, liquidated damages (LD) may be levied at the rate  $\frac{1}{2}$  % of the contract value per day of delay or part thereof subject to 100 % of the contract price.

- (11) Taxes:  
GST Clause:  
The bidder shall quote the price exclusive of GST. The bidder shall quote prevailing GST rate separately, which shall be reimbursed by DPT after ascertaining necessary compliance as per Goods & Service Tax, 2017.  
All other duties, taxes, cesses applicable if any, shall be borne by the contractor.

**Deduction of Income-Tax:**

Income-Tax deductions and surcharge as applicable thereon shall be made good while making payments due to the contractor for carrying out the work and only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.

**Tax:** The rates quoted by the bidder shall be deemed to be inclusive of the taxes, duties etc. which the contractor will have to pay for the performance of this contract, except GST. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.

**Deduction:**

Deduction of taxes / income tax at source shall be made from the any bill of the Contractor in accordance with the prevailing rules of Govt.

Any dues arising out of failure on the part of the Contractor to carry out any obligation under the contract shall be deducted from the bills of the Contractor or from any money due to the Contractor from this contract or any other contract.

- (12) While performing under the contract, the damages caused by the Contractor or his workers to any of the Port Authority property shall be promptly made good by the Contractor at his own cost. In case the Contractor fails to repair / replace the damage, DEENDAYAL PORT AUTHORITY shall have the right to take steps to make good the damages and all the cost on this account shall be recovered from the bills of the Contractor or any money due to the Contractor from this contract or any other contract or any other transaction. In determination of the damage, the opinion of the Engineer-In-charge (EIC) shall be conclusive.

- (13) The rates shall remain valid for a period of 120 days from last date of receipt of budgetary offer.
- (14) The Port Authority will also be at liberty to deduct from performance guarantee or from any sums of money due or that may become due under any contract with the contractor that may become due to the employer. This is without prejudice to the rights of the employer under the terms of the contract.
- (15) XEN (M) reserves the right to cancel the quotation without assigning any reasons and also increase / decrease the quantum of work.
- (16) Copy of GST Registration no. & PAN should invariably be submitted along with the bid quotation, failing which bid / quotation will be considered as non-responsive and be liable to discharge.
- (17) Force Majeure: This shall be restricted to act of god only.
- (18) Correction if any should be signed / initiated by the contractor. White ink correction will not be allowed and lead to rejection of quotation.
- (19) The contractor will follow all the labour laws.
- (20) All the rules and regulation governing DPA will be applicable.
- (21) Tender documents fee of Rs. 590 /- (Including GST) shall be submitted in the form of Demand Draft / Pay Order / BC in favour of "FA & CAO, Deendayal Port Authority" payable at Gandhidham in separate cover attached with the main cover. The Quotation not accompanied with tender fee and EMD shall not be considered & their price bid will not be opened.
- (22) EMD of Rs. 3,526/- (Rupees Three Thousand Six Hundred Thirty One Only) shall be submitted in the form of Demand Draft / Pay order / Bankers Cheque in favour of " Deendayal Port Authority" payable at Gandhidham.
- (23) EMD of the bidders other than L-1 & L-2 will be released within seven days from date of opening of the quotation.
- (24) The Schedule - B (Price bid) to be submitted on-line shall be signed digitally by a person or persons duly authorized to sign on behalf the Bidders. The Schedule - B (Price bid) should not be submitted in hard copy along with other required documents.

(25) Submission of Bids:

The quotations shall be submitted on line through n-procure on or before the due date.
