The Deendayal Port Trust (formerly known as Kandla Port Trust) is a vibrant, world-class multi-cargo Port offering services at multiple locations and having a dominant share of regional cargo by virtue of its ability to effectively leverage its locations and land resources for facilitation of growth of economic activities and investments, with the objective of developing mutually beneficial and sustainable linkages with port based industries and users. Thereby, making Kandla the driver of economic growth in the region and India.

The Deendayal Port Trust invites applications from eligible and competent persons for engagement as Business Development Team purely on contractual basis for the posts as under:

1. Business Development Team Leader – One Post

Qualification: Any degree from recognized National/International University/Institution with Post Graduation Degree / MBA / equivalent from a recognized University / Institution having specialization in Marketing or Shipping or Logistics or Transport or Trade commerce.

Experience: Five years working experience with the reputed organization in the field of Business Development and Trade Promotion in a Service Sector / Public Sector / Private Sector entities. Preference will be given for Port / Shipping Sector experience.

Type of Employment: Contractual.

Tenure of contract: Three years extendable on same terms and conditions for further period of two years, subject to satisfactory performance.

Remuneration: Fixed Rs. 1,00,000/- (Rupees One Lakh Only) per month.

Other Facilities: TA/DA will be paid at par with Dy. HoD post of DPT. Suitable Port Accommodation will be provided, subject to availability of the Port Quarters. OPD facility at DPT hospital to the incumbent and his/her spouse will be provided.

2. Business Development Executive – Four Posts

Qualification: Any degree from recognized National/International University/Institution with Post Graduation Degree / MBA / equivalent from a recognized University / Institution having specialization in Marketing or Shipping or Logistics or Transport or Trade commerce.

Experience: Three years working experience with the reputed organization in the field of Business Development and Trade Promotion in a Service Sector / Public Sector / Private Sector entities. Preference will be given for Port / Shipping Sector experience.

Type of Employment: Contractual.

Tenure of contract: Three years extendable on same terms and conditions for further period of two years, subject to satisfactory performance.

Remuneration: Fixed Rs. 50,000/- (Rupees Fifty Thousand Only) per month.

Other Facilities: TA/DA will be paid at par with entry level Class I Officer of DPT. Suitable Port Accommodation will be provided, subject to availability of the Port Quarters. OPD facility at DPT hospital to the incumbent and his/her spouse will be provided.

Roles and Responsibilities of the BDC Team:

- To provide Strategic vision & Plan in the implementation of various Business Development and Trade Promotion initiatives of the Port.
- Responsible for Managing a team, establishing goals & objectives, managing performance & deliverables and developing & monitoring staff.
- Responsible for creating image building of the organization and bringing additional throughput to the port.
- Responsible for promotion and optimal utilization of the port properties, facilities and services with existing and potential customers and maximizing the economic benefit to the community and region resulting from the activities of the Port.
- To focus on any strategic tie ups/long term relationships with customers, Port authorities or similar such entities to foster growth and efficient Port operations.
- Any work assigned by Chairman or Chief Engineer / Traffic Manager / Secretary and to conduct various business promotion activities at various places in India, as and when required. However, the team will directly report to Chairman.

General Instructions / Conditions:

1. Only Indian Nationals are eligible to apply. While applying for the post, the applicant should ensure that he/she fulfills the eligibility criteria and other norms mentioned above. 
4. The crucial date for determining the eligibility criteria for qualification, experience and age shall be 30/11/2019.
