1. The auction is on "As is where is basis".
2. In case, the H-1 offer is less than the R.P. for any of the vessel the Committee may recommend for accepting the same with approval of competent authority.
3. All Statutory / Mandatory clearance to be obtained from relevant authority by the party and the cost to be borne by them.
4. The bidder shall pay Pre-bid EMD for lot nos. 1) Prahari & Rakshak - Rs. 20,000/-, 2) Mrinal - Rs. 10,000/-, 3) For Vijay - Rs. 10,000/-, 4) For Vaishali - Rs. 10,000/- and 5) For Unnati - Rs. 10,000/- e-auction through M/s. MSTC, Vadodara.
5. The MSTC, Vadodara will be requested to publish / host the invitation of auction for these Mooring Launches in various means of advertise for vide participation.
