CIRCULAR

Ministry of Ports, Shipping and Waterways (Ports Wing) vide Letter No. PF-12019/31/2021-PD-IV dtd. 25.04.2021 has directed to give priority for handling of vessels containing COVID related cargoes. All the respective stakeholders are directed to follow the guideline as given under to avail the express corridor service for handling COVID related cargoes-

1. Highest priority shall be given in the berthing sequence to the vessels carrying consignments of Medical Grade Oxygen, Oxygen Tanks, Oxygen Bottles, Portable Oxygen Generators, Oxygen Concentrators, Steel Pipes for manufacturing Oxygen Cylinders and associated equipment for the next Three months or until further orders. To claim highest priority in next day berthing, agent has to declare the vessel under highest priority with label as "COVID related cargo" in priority column.
2. Agent has to declare vessel atleast 24 hour in advance and has to submit copy of relevant documents like IGM.
3. Waive-off all charges levied by Major Port Trust (including vessel related charges, storage charges etc.) for the above mentioned Oxygen related cargo. Based on copy of a IGM/Bill of Entry and declaration by vessel agent waiver off charges shall be decided by competent authority.
4. Priority will be given for storage of such cargo as per importer/CHA's requirement.
5. Clearance priory will be given to such cargo without any waiting at gate with submission of required import documents.
6. Delivery supervisor shall give priority for delivery of such cargo.
7. CHA can submit list of vehicles/trucks required for evacuation of cargo in advance to CISF for smooth movement of vehicles.
