1. The total length of the pipeline from Single Mooring Point (SPM) to Land Fall Point (LFP) shall be 19.00 KM from which 3.25 KM shall be fall under inter-tidal area and remaining 15.75 KM shall be fall under off shore area.
2. The diameter of the pipeline shall be 48.00 inch.
3. You shall have to take necessary clearance for Crude Oil Terminal (COT) before commencing construction activities of COT and other related facilities.
4. You shall have to obtain CRZ Clearance for the pipeline falling under inter-tidal area.
5. You shall have to comply with all the conditions of Environment Clearance as and when it is granted to you by Ministry of Environment and Forest.

- 3.4 The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75dB(a) during day time and 70 dB (A) during night time. Daytime is reckoned in between 6 a.m. and 10 p.m. and nighttime is reckoned between 10 p.m. and 6 a.m.

5. CONDITIONS UNDER HAZARDOUS WASTE:

- 6.5 In case of any accident, details of the same shall be submitted in Form – 5 to Gujarat Pollution Control Board.
- 6.6 As per "Public liability Insurance Act – 91" company shall get Insurance policy, if applicable.
- 6.7 Empty drums and containers of toxic and hazards material shall be treated as per guideline published for "management & handling of discarded containers". Records of the same shall be maintained and forwarded to Gujarat Pollution Control Board regularly.

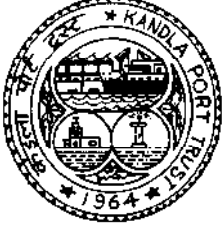

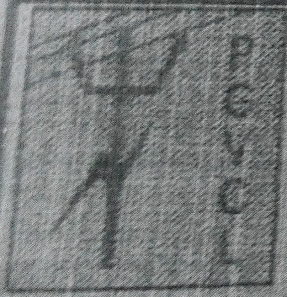
