## C I R C U L A R

**Sub:** Regarding Renewal of License for Stevedoring & Shore Handling Activities under DPA (Stevedoring & Shore Handling) Regulations, 2019.

It is to inform that the validity of license for Stevedoring & Shore Handling activities at Deendayal Port issued under (Stevedoring & Shore Handling), Regulations, 2019, which has been published in the Official Gazette vide Notification dated 19<sup>th</sup> March, 2020 under Section 123 of MPT Act, 1963 is being expired on 31/03/2023.

2. The ceiling rates for Stevedoring and Shore Handling Operations for various commodities of Deendayal Port will be applicable as per prevailing upfront tariff.
3. The Board vide Resolution No. 138 dated 16/12/2022 has also approved the royalty per tone for various commodity for one year after date of implementation. (copy enclosed for reference – Annexure- II)
4. All the existing Registered Stevedores to whom license have been issued are required to Renew for further period of three years under Deendayal Port Trust (Stevedoring & Shore Handling), Regulations, 2019, if they desire so. Otherwise, the said license may be treated as cancelled.
5. Further, fresh applications for new license will follow the procedure stipulated in DPA (Stevedoring & Shore Handling), Regulations, 2019 for Stevedoring & Shore Handling activities at Deendayal Port.
6. Therefore, Composite Application Form for the same may be obtained from the Office of Traffic Manager, Deendayal Port Authority, Ground Floor, Shramdeep, Near Nirman Building, New Kandla between 11.00 hours to 15.00 hours on all working days on payment of Rs. 590/- (Rupees Five Hundred ninety only) inclusive of GST. Alternatively, the Application Form can also be downloaded from our website [www.deendayalport.gov.in](http://www.deendayalport.gov.in) subject to remittance of the application form fee at the time of submission of the form.
