- (i) To authorize Chairman, DPA to submit the SFC memorandum for new requirement of HMCs, subject to ratification of Board;
- (ii) To discharge the invited Tender No. EL/AC/2764 for the work of "Design, Manufacture, Supply, Erection, Testing, Commissioning & Operation of 02 nos. of 100 ton or above capacity of Mobile Harbour Cranes at Dry Cargo Berths, including Comprehensive AMC with operation for a period of five years" due to non-response till date; and
- (iii) To discharge the invited Tender No. EL/AC/MHCHIRE/2022 for the work of "Grant of License for Supply, Installation, Commissioning, Operation & Maintenance of 2 nos. of 100 MT or above owned/hired/leased Mobile Harbour Cranes at Berth No.13 to 16 inside Deendayal Port for a period of five years, extendable on the basis of condition survey and performance on mutually agreed consent for handling the cargo on common user basis" due to non-response till date.
