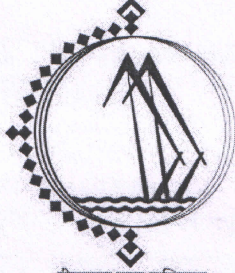

Upon Submission of the study report (Remaining 50%)	25,49,652.50 + 18% GST


