Sub: Constitution of the Board of Major Port Authority of Deendayal Port and Re-naming of Deendayal Port Trust as Deendayal Port Authority – reg.

WHEREAS, the Ministry of Ports, Shipping & Waterways, has appointed the 3rd day of November, 2021 as the date on which the provisions of the Major Port Authorities Act, 2021 (1 of 2021) shall come into force, vide the Gazette Notification No.S.O.4504 (E) dated 29.10.2021. Accordingly, the Major Port Authorities Act, 2021 came into force w.e.f 03.11.2021.

AND WHEREAS, the MoPS&W, thereafter, constituted the First Board of the Major Port Authority of Deendayal Port, under Sub-Section (1) of Section – 3 of the Major Port Authorities Act, 2021, vide Gazette Notification No.G.S.R 57 (E) dated 28.01.2022;

AND WHEREAS, the Board of the Major Port Authority of Deendayal Port, at its first meeting, held on 28.02.2022, resolved vide Resolution No.15 that the existing name of 'Deendayal Port Trust' shall be known henceforth as 'Deendayal Port Authority' and for sake of brevity as 'DPA'. Further, the 'Board of Trustees of Deendayal Port Trust', shall be known as 'the Board of Deendayal Port Authority'. The said changes shall be effected in all the Nameplates, Seals, Letterheads, Logo, Signages etc., wherever the name 'Deendayal Port Trust' is appearing.

NOW, THEREFORE, all Department (s) / Division (s), are directed to carry out the above effects in all Contracts, Finance, Legal Proceedings, DPA Properties and all related matters. The changes as mentioned above, shall be published in the State Gazette Notification, local Newspapers, DPA's Web Portal etc., for information of the Public at large.
