SCOPE OF WORK

[A] Ro-Pax Operation

- 1. The scope of work includes procurement/ leasing/ chartering, deployment and operating Ro-RoPax & Fast Passenger Vessels between origin-destination pair.
- 2. The Operator shall have exclusive operational control of the Terminals including their respective marine infrastructure for
 - a. Berthing/unberthing of RoPax and Fast Passenger Vessel.
 - b. Loading & unloading of vehicles, cargo trucks, passengers, coaches/buses.
 - c. Acceptance, conduct and discharge of Passengers, passenger vehicles and cargo vehicles.
- 3. The Operator has the liberty to operate Ro-Pax and Fast Passenger vessels of any nationality or Origin as per Standard Regularity Framework of GMB.
- 4. The operator shall have liberty to operate the number of Ro-Pax vessels and make number of voyages per day as per his convenience and safe operating conditions provided however that the operator shall adhere to the carrying capacity requirements as detailed below throughout the license period.
 - a. The Ferry vehicle capacity of at least 100 passengers. The criteria can be met by proposing single or maximum two vessels and for this purpose the two vessels which meet this minimum criteria will be treated as one "Unit Vessel". The small capacity may be allowed to be deployed in the initial period.
 - b. The Operator shall have the liberty to operate the number of RoPax vessels and make the number of voyages per day as per his convenience and safe operating conditions.

The operator shall have liberty to operate the vessel at the terminals at Hazira, Muldwarka, Pipavav, Ghogha from/to any other port facility within or outside Gujarat, however exclusive possession and operational control of the terminals at Hazira, Muldwarka, Pipavav, Ghogha, as stated in Point No. 1 & 2, shall not be applicable. The operator shall be liable to pay all DPA charges (Berth hire & Port Dues) and certain percentage of Revenue share.

[B] Terminal Operation.

- 1. The Operator shall have right to occupy, use, operate and manage the terminals facilities as and when required for operation of Ro-Pax and passenger vessel service which is to be operated.
- 2. The operator shall have the right to sub-lease or have it otherwise occupied as deemed necessary by third parties the designated area and provided that the sub-lease is for a period coterminous with or lesser than the operation period.
- 3. The operator shall be entitled to provide value added and any other related services.
- 4. The Operator shall have the right to alter or add the terminal facilities(except iun the area of future expansion) as may be deemed necessary by the operator at its own cost without compensation from DPA, subject to prior approval of DPA.

[C] General

- 1. DPA will provide required water front and back-up facility at Hazira, Ghogha, Muldwarka, Pipavav on free of cost as per availability.
- 2. In the allotted water front, bidder has to berth the vessel to accommodate the operation of Ro-Ro/ Ro-Pax/ Passenger facility.
- 3. General house keeping, cleaning, overhauling of vessel (wherever required), including water / power consumable on day-to-day basis for vessel shall be incurred by operator.
- 4. The operation of ferry service shall be round the clock may be allowed.
- 5. Vessel operator has to take proper insurances for provided facilities including third party insurance.
- 6. During ferry operation Ferry Operator has to comply all the security and safety requirement and all statutory norms as per standard guidelines.
- 7. The scope of the Operator for Ro-Ro/ROPAX berth Operation will also include the following:
 - a. Operations and management of Operator's Ro-Ro/ ROPAX vessel berthing and un-berthing operations including tugs if required.
 - b. Sale of tickets and operations of vehicles in the marshalling yard, operation of Passenger and Ro-Ro services, collection of all the revenue from ticket, security provision on-board the vessels, etc.;
 - c. Procuring/ leasing/ outsourcing equipment such as baggage scanner, x-ray body scanner, baggage handling equipment/ vehicle and trolleys etc. as per best industry standards;
 - d. Providing all facilities required for day-to-day operation and maintenance such as shore crew for mooring operations, providing suitable gangway/embarkation/disembarkation arrangement for passengers.
 - e. Operator has to maintain neat and clean and do not throw any waste in the sea.
- 8. Operator shall be responsible for all recruitment and training of employees needed to perform the scope of work related to Ferry and Terminal Operations.
- 9. The operator shall take the audit of the vessels and carry out all the repairs periodically

as per the standard practices. Vessels and all associate equipment, machinery and system are to be operated and maintained in strict accordance with the local, State, and National regulatory requirements with no compromise to the safety of passengers, crew or the vessels.

10. The Operator shall develop and execute approved security plan for vessels and Terminal operations. All the plans must be in line with statutory requirements. The operator shall be responsible for vessel emergencies and medical emergencies at docking sites. Operator shall provide required security for safe environment for the customer, manage crowd, or any eventuality during embarkation / disembarkation / during passage.

11. The operator shall appoint a separate qualified and trained security officer alongwith required staff for each terminal for ensuring that no untoward incidents take place

during embarkation, disembarkation and transit.
