Resolved to approve the Deendayal Port Trust Employees' (Conduct) Regulations, 2020, as per the draft proposal placed at Annexure-II, under Section-28 of the Major Port Trusts Act, 1963, and send necessary proposal to the Ministry for further approval of the Central Government under Section 124, ibid.

4. Engagement of local part-time Visiting Specialists to provide OPD <u>consultation/treatment in the Port Hospital, Gopalpuri</u>

Resolved to approve the Proposal: -

(1) To engage 28 Specialists in different Specializations mentioned in the Agenda item as Part-time Visiting Specialists for providing specialized consultation/treatment to the Port beneficiaries in Port Hospital, Gopalpuri, for a period of three (03) years w.e.f. 17th March, 2020 with a provision to extend their services for another period of two (02) years, subject to review of their performance by duly constituted Committee of senior Doctors, with the approval of the Chairman.

- (2) To revise the rates of the visit of the Specialists for a period of 5 years w.e.f. 17.03.2020, as per the details given below
 - Engagement of Specialist for attending Port Hospital, Gopalpuri, on payment of Rs.2,000/- per visit. For Ayurvedic and Homeopathic Specialists, the amount of honorarium shall be Rs.1,500/- per visit.
 - (ii) Rs.1,000/- will be paid to the Part-time visiting Specialist for the extra visit as decided by CMO.
 - (iii) Rs.1,000/- will be paid to the Specialist on panel, who is called by CMO to attend the patient.
 - (iv) Payment of 50% of CGHS rates to the visiting Dentist for performing Dental procedures at Gopalpuri Hospital.
