SCOPE OF WORK

- 1.1 Contractor will satisfy himself with the details of the work to be executed and if considered necessary they should visit the site and get any other information required in this connection.
- 1.2 The scope of work includes Complete repairing of surge wave receiver and tester along with microphone unit with all electronic circuit and connecting cable. During replacement the spares used should be of genuine make.
- 1.3 The scope of work also includes repairing and calibration of the surge wave receiver.
- 1.4 The Contactor after carrying out necessary repair work of the machine should give demonstration at site detecting underground fault of both L.t & H.T cable at site
- 1.5 The contractor should give warranty of 6 (Six) months. The contractors have to rectify the defects if any during guarantee period free of cost, failing which the cost of repairing shall be adjusted from security deposit.
- 1.6 The rate should be inclusive of all Taxes exclusive GST.

2. Commercial Conditions

- 2.1 Taxes & Duties : GST Extra @ 18% Income Tax & GST will be deducted at applicable rates.
- 2.2 Payment Terms: 100% after completion of complete of each job and on submission of Invoice through RTGS.
- 2.3 Insurance: at the risk & cost of contractor.
- 2.4 Travel, accommodation & local conveyance: Inclusive in the rate quoted above.

- 2.5 The contractor shall give Guarantee for 06 Months against poor workmanship/manufacturing defects, from the date of commissioning the Cable fault detecting machine.
- 2.6 Security Deposit @ 10% shall be recovered from the bill and the SD can be released only after successful completion of guarantee period.

Terms & Conditions

1. The work shall be completed within 30 days from the date of issue of the Work Order.
2. The rates quoted must be inclusive of all taxes and levies (Excluding GST), No claims of contractor shall be entertained on account of any other taxes levied by central / state government or any authorities paid by him.
3. The rates should be quoted in figures and words both, failing which the bid/quotation will be considered as non-responsive and be liable to discharge. In case of difference in figure & words, the rate mentioned in words will be considered.
4. The contractor shall affix SEAL along with SIGNATURE in the quotation, failing which the bid/quotation will be considered as non-responsive and be liable to discharge.
5. The contractor shall study the local working conditions at the site of work before tendering and no claim what-so-ever shall be entertained.
6. The work shall be carried out in accordance with the best standards of workmanship and to the entire satisfaction of the Engineer-in-Charge.
7. The contractor shall give Guarantee for 03 Months against poor workmanship/manufacturing defects, from the date of handing over cable fault finding machine.
8. The contractors have to rectify the defects if any during guarantee period free of cost, failing which the cost of repairing shall be adjusted from security deposit.
9. Security Deposit @ 10% shall be recovered from the bill and the SD can be released only after successful completion of guarantee period.
10. 1st & Final Bill shall be paid after satisfactory completion of the work.
11. Payment will be made by RTGS only after satisfactory completion of work as per actual quantity of work carried out and submission of duly signed bill.
12. SE(E) /XEN (E) reserves the right to cancel the quotation without assigning any reasons and also increase/decrease the quantum of work.
13. The contractor shall not deposit any materials at such a place that may cause inconvenience to the public or staff or nearby offices.
14. The contractor shall execute the work in such a way that not to cause inconvenience to the public or staff or nearby offices and not to cause hindrance to traffic. Necessary barricading shall be done by the contractor at his own cost if required.
15. For the purpose of measurements, the method prescribed in standard code of measurements of the concern work shall be applicable.
16. Income-tax and surcharge as applicable will be deducted from the bill while payment to the contractor for carrying out the work & only net amount shall be paid to the contractor.
17. All tools, plants, scaffolding ladder etc and other machinery etc. required temporary for the purpose of execution of work will have to be arranged by the contractor at his own cost and storing of such tools, plants etc will have to be made by him.
18. All the materials should be got approved from Engineer-in-Charge before put into use.

19. The GST Registration No. & PAN No. should invariably be mentioned in the Quotation, failing which the Quotation will be considered as non-responsive and be liable to discharge.
20. FORCE MAJEURE: This shall be restricted to acts of GOD only.
21. Correction if any should be signed/ initialized by the contractor. White ink correction will not be allowed and lead to rejection of quotation.
22. 1% EMD in form of DD/Pay Order shall be submitted in separate cover in favour of FA & CAO, Kandla Port Trust payable at Gandhidham attached with the main cover.
23. EMD of the bidders other than L-1 & L-2 will be released within seven days from date of opening of the quotation.
24. EMD of the successful bidder will be adjusted against SD.
25. The contractor has to pay road tax, arrange Gate Passes for entry/exit of labours and equipment's / vehicles inside/outside Cargo Jetty area at his own cost from CISF.
26. All the rules & regulations governing DPA will be applicable.
27. Fire Watch permission may be obtained from fire cum safety officer for hot work/ welding work etc.
28. After completion of the work the site should be neatly cleaned by the Contractor.
29. The Contractor shall ensure not to cause any damage to the port properties in the vicinity of work site during execution of work. If any damage occurs due to workmen/machinery of the contractor, the contractor has to make good the loss/damage at his cost.
30. The contractors are requested to visit the site and get acquainted and familiarized with site condition before submitting the offer.
31. In respect of delay in completion of work beyond 60 days, Liquidated Damages (LD) @ ½% of the contract value per week and part thereof will be levied subject to maximum of 10% of contract value. However, if the delay is attributable to KPT, extension for completion of work will be granted without levy of LD.
