

### **Terms & Conditions**

<b>1</b>	The work is to be carried out at Ro-pax Jetty, Hazira, Surat.
<b>2</b>	The work shall be completed within 30 days after issue of work order or clear site of work is given or till finalisation of tender for supply of water whichever is earliest.
<b>3</b>	The quotationer are expected to have full knowledge of the site of work & local working condition before submitting the quotation.
<b>4</b>	The quotationer shall be required to execute the work in such a way so as not to cause any damage / hindrance with the activity going on in near by area.
<b>5</b>	All the rules & regulation governing D.P.A. will be applicable.
<b>6</b>	PAN number & GST registration No. shall have to furnish by Quotationer, failing which the Bid / Quotation will be considered as non – respective and be liable for discharge.
<b>7</b>	Income-tax and surcharge as applicable shall be made while making payment to the quotationers for carrying out the work & only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.
<b>8</b>	Force majeure : This will be restricted to natural calamities and acts of GOD only.
<b>9</b>	1st and Final bill shall be paid after satisfactory completion of work.
<b>10</b>	EMD of Rs. 4,785.00 and Tender fees Rs 590/- (including GST @ 18%) (Non-refundable) bidder have to make payments for Tender fee & EMD only through Digital mode at Deendayal Port Authority. Online transaction Payment Details for Tender fee & EMD (in Hard copy) needs to be submitted
<b>11</b>	EMD of the bidder other than L-1 & L-2 will be released within seven days from date of opening of quotation. EMD of L-1 & L-2 bidder will be released after commencement of work by L1 bidder.
<b>12</b>	Superintending Engineer (P) reserves the right to cancel the quotation without assigning any reasons and also increase/ decrease the quantum of work.
<b>13</b>	The rates to be quoted excluding GST. However, GST element will not be considered for evolution of bid price.
<b>14</b>	The quotationer shall quote the price exclusive of GST. The quotationer shall quote prevailing GST rate separately, which shall be reimbursed by DPT after ascertaining necessary compliance as per Goods & Service Tax, 2017. All other duties, taxes, cesses applicable if any shall be borne by the quotationer.
<b>15</b>	Water will be supplied within a period of 6 hours after giving the order for supply of water at site by the Engineer in charge. In case of delay or unable to fulfilment of demand of water supply as required the penalty at the rate of Rs 20 per KL per Hours shall be levied on the contractor.
<b>16</b>	Payment will be made by RTGS only after satisfactory completion of work and submission of duly signed bill.
<b>17</b>	For the purpose of measurement the method prescribed in standard code of measurement of the concern work shall be applicable.
<b>18</b>	The Contractor shall ensure not to cause any damage to the port properties in the vicinity of work site during execution of work. If any damage occurs due to workmen / machinery of the contractor, the contractor has to make good the loss / damage at his cost.
<b>19</b>	The TDS under GST Act is required to be deducted @ 2% (1% CGST and 1% SGST or 2% IGST) from payment / credit given to contractors /professionals And others for work order/contracts exceeding Rs. 2,50,000.00
<b>20</b>	Laboratory Testing will be done as and when required.As per IS 10500:2012

21	Contractor/service provider/supplier etc. has to ensure timely and proper filling of GSTR 1 so that DEENDAYAL PORT AUTHORITY can avail input tax credit in timely manner. In case DPA not allowed input tax credit due to failure on part of the contractor/service provider/supplier etc., it will be a financial loss to the DPA and therefore same shall be recovered from the payment/deposite of the contractor/service provider/supplier.												
22	<p>Prodecure for dealing with ambigiuties rates</p> <p>That if on check there are differences between the rates given by the contractor in words and in figures or in amount worked out by him, the following procedure shall be followed :-</p> <p>(a) When there is a difference between the rates in figures and in words, the rates which correspond to the amounts worked out by the contractor shall be taken as correct.</p> <p>(b) When the amount of an item is not worked out by the contractor, or if it does not correspond with the rates written either in figures or in words, then the rate quoted by the contractor in words shall be taken as correct.</p> <p>(c) When the rate quoted by the contractor in figures and in words tallies, but the amount is not worked out correctly, the rates quoted by the contractor shall be taken as correct and not the amount.</p>
