TRADE NOTICE

Sub: Rebates/Concessions on Vessel Related Charges

The Competent Authority has sanctioned rebates and concessions on Vessel Related Charges for vessels that are scheduled to discharge or load Coastal/ Foreign consignment of coal or coke at the dry cargo jetties in Kandla harbour, as per the following slabs:

Parcel Size	% Discount on VRC
Parcel size between 40,000 MT to 49,999 MT	20%
Parcel size between 50,000 MT to 59,999 MT	30%
Parcel size of 60,000 MT and above	35%

These discounts shall be applicable to the rates specified in the Scale of Rates against Pilotage, Port Dues, and Berth Hire Charges. The aforementioned rebates will take effect from July 19, 2024, and shall remain in force for a period of six months, subject to review thereafter.

All Port Users and Trade Associations are hereby advised to take due note of the same.
