- 3. The successful Quotationer is required to visit and inspect the site of each plot and carry out the survey work which consists of demarcation of Green hydrogen land situated between Village Kharirohar and Village Padana, which includes demarcation of boundaries by fixing suitable poles at corner.
- 4. The successfully Quotationer shall supply 01 tracing + 2 copies on A4 size white print along with the soft copy of each drawings. The drawings shall includes latitude-longitude of each corners of each plot along with northing, area calculation, size of each plot, key location of plot, complete in all respects. - 7. The EMD of the unsuccessful tenderer will be refunded after 07 days after the declaration of successful tenderer and the E.M.D. of the successful bidder tenderer, will be refunded after the satisfactory completion of work.
- 8. The last date and time for the offline Quotation submission is on 05.09.2024 upto 12.00 hours.
- 9. The offline opening of the bid is on 05.09.2024 at 15:00 Hours.
- 10. The work shall be completed within 60 days from the date of issue of work order.
- 11. The Quotationer should study the local working conditions at site before quoting the rates and no claim what so ever shall be entertained.
- 12. The survey work consists of demarcation of green hydrogen lands supply of tracing, white prints drawings, showing the latitude-longitude of each corners of each plot along with northing, area calculation, size of each plot, key location of plot, complete in all respects. The work includes the cost of all the materials, machinery, labour if any required, etc. & complete as directed by XEN (KL).
- 13. XEN (KL) reserve the right to cancel the Quotation out right without assigning any reasons and also increase/decrease the quantum of work. No any claim on this shall be entertained.
- 14. Only first and final bill shall be paid after satisfactory of the work. Payment shall be made by RTGS only after satisfactory completion work and submission of duly sealed & signed bill. The RTGS details are also required to be submitted along with the Quotation.

15. GST CLAUSE:-

- (I) The contractor shall quote the price exclusive of GST. The contractor shall quote prevailing GST rate separately, which shall be reimbursed by DPA after ascertaining necessary compliance as per Goods & Service Tax, 2017. The contractor should have valid GST registration number to become eligible for participating in the bid. However, GST will not be considered for evolution of bid price. All other duties, taxes, cases applicable if any, shall be borne by the contractor.
- (ii) GST Registration No. shall have to furnish by Quotationer, failing which the Bid/Quotation will be considered as non-respective and be liable for discharge.

- (iii) Copy of goods and Service Tax (G.S.T.) Registration No. and Income Tax Pan No. proof of the tender fees & EMD in closed with cover-1, failing which quotation will be considered non-responsive and be liable to discharge.
 - (iv) The TDS under GST Act is required to be deducted @ 2% (1% CGST and 1% SGST or 2% IGST) from payment / credit given to contractors / professional and others for work order/contracts exceeding Rs.2,50,000/-.
- (v) Contactor / Service provider / Supplier etc. has to ensure timely and proper filling of GSTR 1 so that DPA can avail input tax credit in timely manner. In case DPA not allowed input tax credit due to failure on part of the Contactor / Service provider / Supplier etc., it will be a financial loss to the DPA and therefore same shall be recovered from the payment/ deposit of the Contactor / Service provider / Supplier.
- 16. Force Majeure restricted to acts of the God.
- 17. All rules and regulations governing DPA will be applicable.
- 18. If during execution any variation in quantity is absolute necessary, the same shall be done with prior approval of competent authority and shall be considered by Deendayal Port Authority and will be limited to \pm 30%.
- 19. The work shall be carried out in accordance with the best standards of workmanship and to the entire satisfaction of the Engineer In Charge.
- 20. The contractor shall affix seal along with signature in the quotation, failing which the bid / Quotation will be considered as non-responsive and be liable to discharge.
- 21. The contractor shall ensure not to cause any damage to the port properties in the vicinity of work site during execution of work, if any damage occurs due to workman / machinery of the contractor, the contractor has to make goods the loss/damage at his own cost.
- 22. In case of delay in completion of the contract, penalty shall be levied at the rate of 0.50% of the contract value per week of delay or part thereof, subject to maximum of 10% of the contract price.
