1) SCOPE OF WORK

Online Quotation invited from the parties who are having experience of carrying out works related to fabrication of pipelines. It is strongly recommended to visit the site to understand the nature of works involved and understand the scope of works at his own risk & cost.

The work mentioned under item Sr. No. 1 is related to fabrication of pipelines. The contractor has to remove the pipelines and fabricate them as per original with seamless schedule 40 pipes of make (Tata, Asian & Jindal). The pipelines have to aligned with the new cooling towers. After fabrication 1 coat of primer and 2 coats of finish paints of DFT- 25 micron each coat, shall be applied. Paints shall be supplied by DPT. The pipelines flanges shall be re-used. in case of renewal of existing damaged pipelines otherwise new flanges of at least 20 nos. have to supplied and used during the fabrication of pipelines. The pipelines have to be fitted with new Stainless Steel nuts & Bolts and new Gasket. The maximum length of the pipe line shall as per site convenience keeping in view for ease in maintenance and their repair in future.

The work mentioned under item Sr. No. 2 is related Supply of two nos. of Mono-block pump make – Kirloskar Brother Ltd, Capacity 5 HP, Motor type - KDS-520, RPM 2870, 5HP, 3.7 KW. The Mono-block pump has to aligned with the existing piping of DG set cooling towers and fabrication of new foundation for the both pump as per existing.

The work mentioned under item Sr. No. 3 is related to Supply of 6 nos. of 3-inch valve (Flange type, materials - SS) and their fitment in the piping system to make the interchangeability between both cooling towers and pumps. The purpose of interchangeability in the piping system to incorporate the provision such that in the case of failure of circulating pump or cooling tower another circulating pump or cooling tower may be utilized.

The above work shall be carried out in 2X 1000 KVA DG Set. Some portion of the pipelines have to be renewed and some portion the pipelines have to be fabricated as per site requirement to aligned with the new cooling towers which shall be constructed by DPA Civil Engineering Department. In the existing system of pipelines of cooling tower, there is no provision for the interchangeability between cooling tower and pumps and to make the interchangeability possible with the incorporation of 6 nos. of valves. Accordingly, existing pipelines have to be modified.

2) PRICE

The rate quoted shall, be firm and final inclusive of all taxes, levies, duties, insurance and Transportation charges from Kandla and back etc. excluding GST. The GST may be shown separately which shall be reimbursed as per GST Act, 2017.

3) <u>VALIDITY</u>

The offers shall be valid for 90 days from the date of opening of Quotation.

4) <u>TERMS OF PAYMENT</u>

After submission of bills in duplicate by the contractor, the 90% payment shall be released by RTGS within 30 days of after satisfactory completion of job, inspection, test & trail. The balance 10 % kept as Security Deposit (SD), shall be paid after completion of guarantee defect liability period of six months.

5) **LIQUIDATED DAMAGE**

Liquidated Damage will be levied @ 0.50% of the contract value per week and part thereof will be levied in case of delay in completion work subject to maximum of 10% of contract value. However, if the delay is attributable to DPA, extension for completion of work will be granted without levy of LD.

6) <u>COMPLETION PERIOD</u>

The work shall be completed within 60 days after date of issue of work order.

7) **GUARANTEE PERIOD**

The works shall be under guarantee period of six months, from the date of successful test & trial and completion of the work.

8) Sub-contracting will not be allowed.

- 1. All the rules and regulations governing DPT will be applicable.
