**Global Invitation for Qualification for “Development of Multipurpose Cargo (other than Container/Liquid) Berth off Tuna Tekra outside Kandla Creek at Kandla on BOT basis under PPP mode” for a concession period of Thirty (30) years.**

The Board of Deendayal Port Authority (“**Authority**”) invites Application from interested parties (“**Applicants**”) in accordance with the Request for Qualification (**RFQ**) document in order to pre-qualify prospective Applicants who can subsequently bid for the Project as per Request for Proposal (**RFP**) documents. The estimated cost of the Project is **Rs. 1,552.57 Crores**.

The Applicants shall upload the copy of the transaction details of RTGS/ NEFT / Bank Transfer etc. along with the application for having remitted the tender fee in N-Procure portal, without which the application shall be summarily rejected. The Authority shall not be liable/responsible for any connectivity/internet problem either with the user side/NIC/Bank. It is in the own interest of the Applicants and the Applicants may get it verified from Bank that the requisite money has been received by the Authority for the NIT in which they are participating.
