TERMS AND CONDITIONS

- 1. All tools & tackles, materials, manpower, transportation etc. to carry out the subject work satisfactory shall be arranged by the party at his own cost. Dry dock with electrical supply and fire watch shall be provided by DPA free of cost, however, necessary permission shall be obtained by the party from the concerned department of DPA. The complete work shall be carried out under supervision of IRS surveyor and to the satisfaction of IRS.
- 2. The contractor is recommended to visit the site to understand the nature of the job involved prior to offering the rates.
- 3. Port Entry permit for the labour and material if required shall be arranged by the party. DPA can assist only for issuance of authorization letter.
- 4. All Work shall be guaranteed for six months from the date of satisfactory test and trail at sea after completion of work.
- 5. Work shall be completed <u>30 days</u> from the date of availability of craft at Dry Dock.
- 6. No transportation, accommodation etc shall be provided by DPA.
- 7. The Contractor will follow all labour laws.
- 8. All the rules and regulations governing DPA will be applicable.
- 9. FORCE MAJEURE: This shall be restricted to acts of GOD only.
- 10. During the guarantee period if any defect is found due to material/poor workmanship of the contractor, the cost of repair will be borne by the contractor and rework and other auxiliary work if required is to be carried out by the contractor free of cost including the cost of material.
- 11. The rates quoted must be inclusive of all costs such as tools, tackles, material (except Plate for P- bracket which is to be provided by DPA), labour, transportation etc. (Excluding GST). No claims of contractor shall be entertained on account of other taxes levied by central/ state government or authorities paid by him.
- 12. **GST Clause:** The contractor shall quote the price exclusive of GST. The contractor shall quote prevailing GST rate separately, which shall be reimbursed by DPA after ascertaining necessary compliance as per Goods & Service Tax, 2017. All other duties, taxes, cesses applicable if any, shall be borne by the contractor.
- 13. For any delay in completion of the work which is attributable to the contractor, liquidated damage (L.D.) shall be levied at the rate of ½% (half percent) of the contract value for delay of each week and part thereof subject to maximum of 10 % of the contract value in the event of failure to complete the work within stipulated completion period or such extension as may be granted from time to time.

- 14. After submission of bills in duplicate by the contractor, the 90% payment shall be released as 1st and final bill by RTGS within 30 days of satisfactory completion and test and trial at DPA site. The balance 10 % shall be paid after completion of guarantee defect liability period of six months.
- 15. The work shall be carried out in accordance with the best standard of workmanship and to the entire satisfaction of DPA/IRS.
- 16. Cost of IRS inspection and certification of work shall be paid by DPA to IRS directly.
- 17. DPA reserves the right to cancel the quotation without assigning any reasons and also increase/ decrease the quantum of work.
- 18. Contractor shall be responsible for any damage, theft and fire during the execution of said works for his own and DPA property.
- 19. Income Tax/ Education cess/TDS on GST as applicable shall be deducted at source while making payment to the contractor for carrying out the work and only net amount shall be paid to the contractor.
- 20. The GST Registration No & Income tax PAN no (exemption if any) should invariably be submitted along with the quotation.
- 21. The contractor should strictly follow all statutory rules & regulations like labour law, insurance, safety norms & regulations etc.
- 22. Correction, if any, should be signed / initialed. White ink corrections are not allowed.
- 23. Quotation documents fee of Rs. 590/- (Including GST) EMD of Rs. 4,815/- submitted through <u>Online mode</u> or MSME/NSIC certificate for exemption shall be submitted along with the quotation documents in single sealed cover. The Quotation not accompanied with Quotation fee & EMD or MSME/NSIC certificate (in case of exemption) may not be considered.
