The candidate must possess valid Mark-sheet, Degree Certificate of the prescribed qualification as on mentioned date.

Note 2: Candidates must possess the essential qualifications mentioned against the post. Candidates not possessing certificate of essential qualifications will not be eligible.

Note 3: For Candidates from SC/ST/OBC (NCL) categories, Degree of Second Class in Electrical/Mechanical Engineering will be considered, subject to submitting of Caste Certificate issued by the competent authority in the prescribed format as stipulated by the respective competent authorities of State Government/Govt. of India.

D). <u>ELIGIBILITY CRITERIA:</u>

Candidates, intending to apply for the above posts should ensure that they fulfil the minimum eligibility criteria mentioned above.

The crucial date for determining the eligibility criteria for qualification, experience and age shall be **01.05.2025**.

E). SELECTION PROCEDURE:

- Candidates applying for the above post will be initially shortlisted purely on the basis of merit only. A merit list will be prepared on the basis of marks obtained in educational qualification and experience.
- Candidates from the merit list will be called for Personal Interview in the ratio of 1:3 or availability of eligible candidates, whichever is lower.
- Selection of the candidates will be made from the merit prepared on the basis of final percentage of marks obtained by the candidate in the respective educational qualification required for each discipline i.e. Degree in Electrical Engineering or Degree in Mechanical Engineering, experience possessed by the candidate and marks obtained in the Personal Interview.
- Personal interview will be held by the Selection Committee by giving weightage of marks as under: -

- The provisionally selected candidates will be informed for document verification through their registered E-mail ID. DPA is not liable for delay / loss or non – receipt of e-mail due to incorrect / false / change of registered E-mail ID.
- If the applicant from the merit list does not remain present on the specific date of reporting for document verification OR the details mentioned by candidate in application form is found incorrect/false/incomplete, his/her candidature will be rejected and the next applicant(s) on the merit list will be considered.
- No request from the applicants in above circumstances will be entertained
- Non submission of requisite documents by the candidate during this process will disqualify his / her candidature from further participation in the recruitment process.

If CGPA / C.P. / Grade / Scale / Point or other nomenclature is mentioned in the curriculum, then the same is to be converted into the Percentage Score as per the rules and shall be inserted (out of Maximum Marks i.e. 100). Candidate will himself / herself be held responsible with regard to the correctness of all information and marks declared while filling the application form on Deendayal Port Authority website www.deendayalport.gov.in.
- 5. No correspondence will be entertained / no communication will be made with reference to the incorrect or false details provided by candidate.

H). General Instructions / Conditions:

- 1. Only Indian Nationals are eligible to apply. While applying for the post, the applicant should ensure that he / she fulfils the eligibility criteria and other norms mentioned above. In case, if it is detected at any stage of engagement that a candidate does not fulfil the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after engagement, his / her services are liable to be terminated without any notice.

TERMS & CONDITIONS FOR ENGAGEMENT OF JR. SITE ENGINEER (ELECTRICAL) AND JR. SITE ENGINEER (MECHANICAL) ON CONTRACT BASIS IN MECHANICAL ENGINEERING DEPARTMENT, DPA.

- 1. The Jr. Site Engineers be engaged purely on contract basis for a period of eleven months with a provision to grant two more extensions with adequate break in between each engagement, on satisfactory performance.
- 2. He / She shall be paid fixed monthly consolidated remuneration of Rs.49,000/- per month (Rupees Forty Nine Thousand only), which will remain unaltered for the entire period of contract.
- 3. He / She shall not be entitled to / eligible for any other allowance or financial benefits during the above period of the contract.
- 4. He / She shall carry out the functions / duties assigned to him/her from time to time by the superior officers of the Deendayal Port Authority.
- 5. Their services shall be made use of anywhere in the best manner as the DPA Administration considers it as essential.
- 6. TA / DA on official tour He / She shall be entitled for TA / DA at par with Jr. Engineers of the of DPA.
- 7. Accommodation Suitable Port Accommodation will be provided, subject to availability of the Port Quarters, on application, depending on availability and payment of License Fees under FR-45A.
- 8. Medical Facility OPD facility at DPA hospital, to the incumbent and his / her spouse will be provided.
- 9. <u>Leave</u> He / She shall not be entitled to / eligible for any type of leave during the contract period, except the holidays applicable to Deendayal Port Authority but he/she shall be entitled to avail 11 Casual Leave. In the event of absence from duty for whatsoever reason, the pro-rata amount from the remuneration payable shall be deducted for the period of absence.
- 10. The contract is liable to be terminated by giving a notice of 15 days by either side.
- 11. The Management can terminate the above contract at any time by giving 15 days' notice, without assigning any reason.
- 12. This engagement of contract will stand terminated on completion of contract period or if terminated earlier.
- 13. He / She shall maintain complete confidentiality with regard to information/documents pertaining to the DPA accessed during the course of his assignment.
- 14. He / She shall neither be entitled nor have any claim for any temporary / adhoc employment in DPA during the said contractual period or after completion of the contract.
- 15. Any kind of criminal or civil proceedings that may arise during the contractual period, the Port will not be held responsible in any manner.
- 16. The contractual engagement is subject to being found medically fit as per the requirement of Deendayal Port Authority.

- 17. The contractual engagement is subject to verification of antecedents by the Police. If any adverse report is received from the Police, contractual services are liable to be terminated forthwith.
- 18. In the event of death of a person appointed on "Contract Basis" while in service, the balance contractual amount, due if any, against the work done, will be paid to his / her legal heirs, and no any other financial benefits shall be given.
- 19. The Port is authorized to amend / modify the above Terms & Conditions at any time to suit the requirement of the Port.
- 20. It is specifically clarified that this Contractual Engagement will not confer any right on them for absorption in DPA at any time.
- 21. In the event of any dispute arising out of this contract, the interpretation and decision of the Chairperson of the Deendayal Port Authority will be final and binding.

22. Court of jurisdiction for any dispute will be at Gandhidham only.
