**NAME OF WORK: -E-Quotation for the work “Repair of Port Main Engine of Tug Jyeshta.”**

**Scope of work & Special Conditions**

**1) SCOPE OF WORK**

Offline Quotation invited from the parties who are having experience of carrying out **similar works related to repair works of main engine/DG Engine**. It is strongly recommended to visit the site to understand the nature of works involved and understand the scope of works at his own risk & cost. If party require any technical help from Authorized dealer of Caterpillar make engine, he may obtain their help at his cost during the repair work. **Details of Engine Serial no: TTH00554, Engine Model no: 3516C, Power: 1920KW at 1600RPM.**

- i. Heat exchanger (plate type) need to be cleaned. The damaged sealing gasket / O ring need to be renewed. The plate type heat exchanger need pressure tested.
- ii. Valve (exhaust, inlet and injector) lash setting need to be checked and adjusted.
- iii. Sensor of after cooler (1 no.), Sensor of coolant water temperature (1 no.), Sensor of exhaust temperature (1 no.), ECS Switch (1 no.), relay (3 nos.) need to be renewed as they are found defective.
- iv. Sea Water pump need to be replaced with pump supplied by DPA. The removed sea water pump shall be dismantled and overhauled with new seal and bearing.

**2) PRICE**

The rate quoted shall, be firm and final inclusive of all taxes, levies, duties, insurance and Transportation charges from Kandla and back etc. excluding GST. The GST may be shown separately which shall be reimbursed as per GST Act, 2017.

**3) VALIDITY**

The offers shall be valid for 60 days from the date of opening of Quotation.

**4) TERMS OF PAYMENT**

90% payment shall be released by RTGS within 30 days of after satisfactory completion of job, inspection, test & trail. The balance 10 % shall be paid after completion of guarantee defect liability period of six months. Defect liability period of work shall be counted from date of satisfactory completion, test and trial.

**5) LIQUIDATED DAMAGE**

Liquidated Damage will be levied @ 0.50% of the contract value per week and part thereof will be levied subject to maximum of 10% of contract value. However, if the delay is attributable to DPA, extension for completion of work will be granted without levy of LD.

**6) COMPLETION PERIOD**

The work shall be completed within 15 days from date of issue of work order.

**7) GUARANTEE PERIOD**

The works shall be under guarantee period of six months, from the date of successful test & trial.

**8) Sub-contracting will not be allowed.**

**TERMS AND CONDITIONS**

1. All the rules and regulations governing DPT will be applicable.
2. GSTIN No. & Income Tax PAN No. shall have to furnish by Quotationer, failing which the Bid/Quotation will be considered as non-responsive and be liable for discharge.
3. Force Majeure: This will be restricted to natural calamities and acts of GOD only.
4. Submission of fraudulent document shall be treated a major violence of such procedure and in such case Port shall resort to blacklisting the Quotationer for 3 years.
5. GST Clause: The contractor shall quote the price exclusive of GST. The applicable GST shall be paid extra to the contractor after producing GST Invoice as per the certified Bill by the department. However, element of GST shall not consider for evaluation of bid. 'Contractor/service provider/ supplier etc. has to ensure timely & proper filling of GSTR 1 so that Deendayal Port Authority can avail input tax credit in timely manner. In case DPT not allowed input credit due to failure of part of the contractor/ service provider/ supplier etc., it will be a financial loss to DPA & therefore same shall be recovered from the payment/ deposit of the contractor/ service provider/ supplier.
6. TDS ON GST: TDS provision under GST Acts, 2017 are in force from 01.10.2018 and accordingly TDS under GST Act will be deducted @ 2 % (1% CGST and 1 % SGST or 2 % IGST) from payment / credit give to contractor / contract / professional and other for work order / contract exceeding Rs.2,50,000/-.
7. Deduction of Income-Tax and GST: Income-Tax deductions and surcharge and GST+TDS provision under GST Act as applicable thereon shall be made good while making payments due to the contractor for carrying out the work and only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.
8. Tax: The rates quoted (except GST) by the contractor shall be deemed to be inclusive of the taxes, duties etc. which the contractor will have to pay for the performance of this contract. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.
9. Quotation documents fee of Rs.590/- (Including 18% GST) and EMD of 1% of estimated cost (Rs. 4740/-) shall be submitted online in favour of Deendayal Port Authority, BANK OF BARODA, Gandhidham, Account No. 10080100022427, IFSC Code: - BARB0GANKUT.
10. EMD of the bidders other than L-1 will be released within seven days from date of opening of the quotation.
11. EMD of the successful bidder shall be refunded after successful completion of the work.
12. The contractor has to arrange Gate Passes for entry/exit of labours and equipment's / vehicles inside/outside Cargo Jetty area at his own cost from CISF.
13. CME reserves the right to cancel the quotation without assigning any reasons and also increase/decrease the quantum of work.
14. The rate to be quoted excluding GST, no claims of contractor shall be entertained on account of any other Taxes levied by Central / State Govt. or any authorities paid by him.
15. Payment will be made by RTGS only after satisfactory completion of work, test & trial.
16. The E-Quotation not accompanied with Quotation fee & EMD shall not be considered & their technical and price bid will not be opened.

17. In case of Micro and Small Enterprise (MSEs) holding valid certificate issued by any agencies/organization under The Ministry of Micro, Small and Medium Enterprises indicating the sub-class list of activity related to the subject tender as per National Industrial Classification-2008 mentioned in the table below only shall become eligible for exemption from payment of Quotation fee/EMD. Such bidder shall upload the scanned copy of valid certificate in preliminary bid.
