#### Dear sir,

Under the Greenbelt development project, the Plantation of 10,000 saplings have been developed during the second phase and the project has been completed on 23rd September

The plantations need to be managed by regular watering, soil enrichment work, applying manure, weeding and provide proper protection along with gap filling, if any mortality occurs in the plantations. In general, plants requires after care for a period of minimum two to three years after the plantations, till the saplings attain matured tree stage. Watering of sapling is required under Kachchh climatic scenario, therefore watering needs to be carried out once in 2 or 3 days as per the season for a period of two to three years. We are recommending maintenance for two years for the phase-II plantation, i.e., 2025 and 2026.

We hereby submitting a budget along with the commercial for the "Maintenance of Greenbelt Development in Deendayal Port Authority at Kandla (Phase-II)".


