Scope of Work (Tentative) & Other details

Name of Work: -_"Review of prevailing schedule of Rates (SOR) 2022 for Civil works and subsequent framing of Revised and updated SOR."

A. Scope of work:-

- 1) Collection of prevailing SOR and Detailed SOR of CPWD and Gujarat PWD etc for civil works.
- 2) Compare prevailing SOR 2022 of DPT with prevailing SOR of CPWD and Gujarat PWD etc and make comparative statement.
- Detailed & comprehensive analysis of above comparison including identification the items under SOR of CPWD, Gujarat PWD etc which can economically & practically be adopted by DPT for normal civil works i.e works other than specialized/ marine works.
- 4) Review of prevailing SOR of DPT in terms of updated technology, prevailing Market rates etc.
- 5) Submit detailed Report on outcome of above tasks and make presentations report before concerned Port officials and get suggestions of thereon and raise the report accordingly.
