- 1. Delivery Period: 45 Days from the date of receipt of supply order.
- 2. The rates quoted must be inclusive of all taxes levies (Excluding GST), No claims of contractor shall be entertained on account of any other taxes levied by central/state government or any authorities paid by him.
- 3. The contractor shall study the local working conditions at the site of work before tendering and no claim what so ever shall be entertained.
- 4. The work shall be carried out in accordance with the best standards of workmanship and to the entire satisfaction of the Engineer in charge.

5. Payments Terms:

100% payment will be release after supply of material mentioned in Annexure-A will made by DPA on actual basis after receipt of the material in good condition.

- 6. SE (E) reserve the right to cancel the quotation without assigning any reasons and increase/decrease the quantum of work.
- 7. All tools, plants, scaffolding ladder etc., and other machinery etc. required temporary for the purpose of execution of work will have to be arranged by the contractor at his own cost and storing of such tools, plants etc. will have to be made by him.
- 8. All the material should be approved from Engineer-in-charge before put into use.

9. TDS ON GST

TDS provision under GST Acts,2017 are in force from 01.10.2018 and accordingly TDS under GST ACT will be deducted @2% (1% CGST and 1% SGST or 2% IGST) from payment/credit give to contractor/contract/professional and other for work order /contract exceeding Rs.2,50,000/.

10. Deduction of income-tax and GST:

Income-Tax deduction and surcharge GST+TDS provision under GST Act as applicable thereon shall be made good while making payment due to the contractor for carrying out the work and only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.

11. The contractor has to arrange Gate Passes for Entry/Exit of labours and

equipment's/vehicles inside/outside Cargo Jetty area at his own cost from CISF.

- 12. All the rules & regulation governing DPA will be applicable.
- 13. The Contractor shall ensure not to cause any damage to the port properties in the vicinity of work site during execution of work. If any damage occurs due to workmen/machinery of the contractor, the contractor has to make good the loss/damage at is cost.
- 14. Taxes & Duties: GST Extra @ 18% Income Tax & GST will be deducted at applicable rates.
- 15. Travel, accommodation & local conveyance: Inclusive in the rate quoted above.
