## **TERMS AND CONDITIONS**

- 1. The validity of this quotation shall be valid till 120 days.
- 2. The firm is required to deliver the Standard Weights as per referred specifications inside Cargo Jetty Area, Deendayal Port New Kandla, within 60 days from issuance of Supply Order.
- 3. Delivery of Standard Weights will be completely in scope of contractor and DPA will only provide administrative support, without any risk and cost.
- 4. Liquidate Damage: In case of delay in completion of the work, liquidated damages (LD) may be levied at the rate of ½ % of the entire Supply Order value per week of delay or part thereof, subject to maximum of 10% of the entire contract price.

- 5. All the Rules & Regulations governing Deendayal Port Authority will be applicable.
- 6. Income Tax / Education Cess as applicable shall be deducted at source.
- 7. The Rate quoted is inclusive of labour charges, certification of verification, duties & taxes, levies, transportation, tools and tackles, insurance, stamping fee, road tax, e-Way bill, loading & unloading and all other auxiliary charges etc. except GST (under GST Act, 2017). No extra payment will be made, for whatsoever reason, by Deendayal Port Authority.
- 8. The payment shall be released, through RTGS / NEFT after the delivery and complete verification and stamping of Standard Weights including its certificate issued by Govt. authority and accepted by the DPA (with provision of part payment of 50 % amount), within 30 days; for which party has to submit the invoice and bank details in triplicate. The bills must have GSTIN No. of the party as well as GST No. of DPA (GSTIN No. of DPA is 24AAALK0046N1Z6).
- 9. DPA will not be responsible for any loss, damage or accident to any of the staff, while delivery of material.
