Terms & Conditions

- 1 The work shall be carried out in DPA A.O Building Jetty, Vadinar
- All the precaution regarding the safety of workers shall have to be taken by the contractor at his own risk & cost.
- All the required materials, tools, plants, ladder other machinery etc. and, storage charges, transportation, insurance, survey fee, consultation charges etc. for the purpose of execution of work will have to be arranged by the contractor at his own cost.
- 4 Income Tax with surcharges if applicable shall be deducted from the bill as per rules applicable.
- 5 The work should be completed within period of 10 Days after issuing the work order.
- 6 The contractor or authorized person shall remain present at site during working hours.
- Executive Engineer [Civil] reserves the right to cancel the quotation without assigning any reason and also increase / decrease the quantum the work.
- 8 The Contractor shall furnish PAN number, GST number along with quotation.
- 9 Force majeure restricted only to the acts of GOD.
- All the rules and regulations governing DPA will be applicable.

In case of Micro and Small Enterprise [MSEs] holding valid certificate issued by any agencies/organization under The Ministry of Micro , Small and Medium Enterprises indicating the sub-class list of activity related to the subject Quotation as per National Industrial Classification-2008 mentioned in the table below only shall become eligible for exemption from payment of quotation EMD . Such bidder shall upload the scanned copy of valid certificate in preliminary bid as well as duly filled and signed "Bid Security Declaration" as per format provided in the Quotation document (**Form no 01**) failing which the bid shall be considered non-responsive bid.

12 Financial bids: The quotation paper duly sealed and signed on each page, duly filled in Bill of quantities

- 13 EMD of the bidders other than L1& L2 will be released within 7 days from the date of opening of the quotation EMD of L2 will be released on issue of work order to L1 party and that of L1 party be released after payment of final bill.
- Special Condition for GST: Applicable GST on the taxable value of supply of Goods or Services or both covered in this Quotation/contract will be paid by Port as reimbursement on production of documentary evidences/reflection of the same under the GSTIN of DPT in GST web portal. Applicable statutory recoveries including TDS under Income tax, TDS under GST acts will be deducted/recovered while accounting for or making payments to the vendor as per the applicable laws.
- 15 If the party is produced wrong PAN no/Invalid PAN no, than as per the income tax rules income will be recovered@20%.
- After completion of the work the area should be neatly cleaned by Contractor. No payment shall be given to contractor on this account.
- 17 All material should be got approved by Engineer-in-charge before use and No advance payment shall be given to contractor on this account.
- 18 The quoted rate must be inclusive of all tax and levies (excluding GST) no claims contractor shall be entertained on account of any other taxes levied by central/state government or any authorities paid by him.
- 19 **Payment Terms**: Payment will be made after completion of work as per terms and conditions and satisfaction of Engineer-in-charge on production of three copies of the bills duly signed sealed by the authorized representatives of the party and verified by Engineer-in-charge. Payment will be made by NEFT/RTGS only in the final bill after completion of work.

20 Liquidated Damages/Penalty, if any:

- (A). In case of delay in completion of the contract, liquidated damages (L.D) may be levied at the rate of ½ %of the contract value per week of delay or part thereof, subject to a maximum of 10 percent of the contract price.
 - a. The Employer if satisfied, that the works can be completed by the contractor within a reasonable time after the specified time for completion, may allow further extension of time at its discretion with or without the levy of L.D. In the event of extension of time at its discretion with L.D, the employer will be entitled without prejudice to any other right or remedy available in that behalf per cent (1/2%) of the contract value of the works for each week or part of the week subject to the ceiling defined in subclause 20(A).
 - b. The Employer, if not satisfied that the works can be completed by the contractor,

- and in the event of failure on the part of the contractor to complete work with in further extension of time allowed as aforesaid, shall be entitled, without prejudice to any other right, or remedy available in that behalf, to rescind the contract.
- c. The Employer, if not satisfied with the progress of the contract and in the event of failure of the contractor to recoup the delays in the mutually agreed time frame, shall be entitled to terminate the contract. In the event of such termination of the contract as described in clauses 20A (b) or 20A (c) or both the owner shall be entitled to recover L.D. up to ten per cent (10%) of the contract value and forfeit the security deposit made by the contractor besides getting the work completed by other means at the risk and cost of the contractor.
- d. The ceiling of L.D. shall be 10% of the cost of work.
- e. In case part/portion of the work can be commissioned and port operates the portion for commercial purpose the rate of L.D. will be restricted to the uncompleted value of work, the maximum L.D. being on the entire contract value.
- 21. Decorative wall PVC sheet (Ist quality) and floor carpet (2mm thick make of Wonder floor or equivalent co.) work shall be carried out with Ist quality materials and as per directed by EIC
- 22. Curtain with Palmet for windows with all accessories and Fittings shall be used Ist quality and make of Sipeko or Dera or equivalent co. as per approved and directed by EIC.
- 23. The security deposit at 10% recovered from the bill and the security deposit can be released only after 03 months, successfully completion of the work.
- 24. The Contractor shall visit the site and study the local working condition at site of work before quoting the rate and no claim what so ever shall be entertained.
