TERMS AND CONDITIONS

- (1) Deendayal Port Authority intends to carry out the work of Shifting and upgradation of non-operational boat ML Rakshak from AO building (gate-2) to Centre of Excellence with Green Maritime concept as per the Scope of Work, including but not limited to, making foundation stands, complete cleaning and painting, FRP repairs, sign & glow boards, fenders, beautification, decorative lighting, Green Maritime concept display e.g. Green Hydrogen, Battery, Green Methanol, seating arrangement inside boat wheel house, access ladder, Solar panel with battery backup for lighting of boat in auto mode, etc. as directed by Engineer-in-charge.
- (2) Time Schedule: The work shall be completed within 30 days from the date of receipt of Work Order.
- (3) Quotationer at his own responsibility and risk is encouraged to visit and examine the site of work and its surroundings and obtain all information that may be necessary for successful execution of work. The costs of visiting the site shall be at the Quotationer's own expense performance including all warranty obligations as per Technical Specification, General & Special conditions of Contract.
- (4) DPA will award the work to the quotationer whose quotation is the lowest evaluated amount Quotation. The responsive quotation shall be considered which are received as per Schedule – B and Terms & Conditions, duly filled, signed & stamped, along with the self-attested copy of valid GST & PAN certificate.
- (5) CME reserves the right to cancel the quotation without assigning any reasons.
- (6) The Quotationer shall affix SEAL along with SIGNATURE in the Quotation.
- (7) Work shall be guaranteed for 12 months from the date of completion of the work.
- (8) Payment Terms: 95% payment will be released after successful completion of work accepted by DPA. The payment shall be in Indian Rupees.
- (9) Security Deposit @ 5% will be recovered from the bill and the SD can be released only after successful completion of guarantee period.
- (10) In case of delay in completion of the contract, liquidated damages (LD) may be levied at the rate of 1/2% of the contract value per week of delay or part thereof, subject to maximum of 10% of the contract price.
- (11) Payment will be made by NEFT/RTGS only after satisfactory completion of work and submission of duly signed bill as per DPA format.
- (12) **GST:**

The bidder shall quote the price exclusive of GST. Applicable GST on the taxable value of supply of Goods or Services or both covered in this tender/contract will be paid by Port on production of required document as per prevailing rules as per Goods & Service Tax Act, 2017. All other duties, taxes, cesses applicable, if any, shall be borne by the bidder. Applicable Statutory recoveries including TDS under Income Tax, TDS under GST acts will be deducted/ recovered while accounting for or making payments to the bidder as per the applicable laws.

Contractor / Service provider / Supplier etc. has to ensure timely and proper filling of GSTR 1 so that Deendayal Port Authority can avail input tax credit in timely manner. In case DPA not allowed input tax credit due to failure on part of the contractor/Service provider/Supplier etc., it will be a financial loss to the

DPA and therefore same shall be recovered from the payment/deposit of the contractor/service provider/supplier.

Deduction of Income-Tax:

Income-Tax deductions and surcharge as applicable thereon shall be made good while making payments due to the contractor for carrying out the work and only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.

Rate &Tax:

The rates quoted by the contractor shall be deemed to be inclusive of the excise, other taxes, duties etc., but exclusive of the GST (CGST & SGST), which the contractor will have to pay for the performance of the contract. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.

- (13) The rates should be quoted in figures and words both. In case of difference in figure & words, the rate mentioned in words will be considered.
- (14) The work shall be carried out in accordance with the best standards of workmanship and to the entire satisfaction of the Engineer-in-charge.
- (15) The contractor shall not deposit any materials at such a place that may cause inconvenience to the public or staff or nearby offices. Any material removed from the boat shall be property of DPA and same shall be returned to DPA main store Kandla.
- (16) The Contractor shall execute the work in such a way that not to cause inconvenience to the public or staff or nearby offices and not to cause hindrance to traffic. Necessary barricading shall be done by the contractor at his own cost if required.
- (17) All tools, plants, scaffolding, ladder etc. and other machinery etc. required temporary for the purpose of execution of work will have to be arranged by the contractor at his own cost and storing of such tools, plants etc. will have to be made by him.
- (18) All the materials should be got approved from Engineer-in-Charge before put into use.
- (19) Correction if any should be signed / initialed by the contractor. White ink correction will not be allowed and lead to rejection of Quotation.
- (20) All the rules and regulations governing DPA will be applicable.
- (21) After completion of the work, the site should be neatly cleaned by the contractor.
- (22) The quotationer shall ensure not to cause any damages to the port properties in the vicinity of work site during execution of work. If any damage occurs due to workmen/ machinery of the contractor, the contractor has to make good the loss / damage at his cost.
- (23) For Entry & exist of material and quotationer personnel, pass shall be arranged by contractor.
- (24) Quotationer has to arrange their own transport arrangement for shifting of materials including deposit of materials to main store kandla.
- (25) All the work shall be carried out to the entire satisfaction of Engineer-in-charge.

- (26) FORCE MAJEURE: This shall be restricted to acts of GOD only.
- (27) Quotation documents fee of Rs. 590 /- (Including GST) and EMD of Rs. 4,970/- (Rupees Four Thousand Nine Hundred Seventy Only) shall be submitted through online transfer in Name of beneficiary: Deendayal Port Authority, Bank of Baroda, Gandhidham Branch, a/c no.: 10080100022427, IFSC Code: BARBOGANKUT. The Quotation not accompanied with quotation fee and EMD shall not be considered & their price bid will not be opened.

In case of Micro and Small Enterprise (MSEs) holding valid certificate issued by any agencies/organization under The Ministry of Micro, Small and Medium Enterprises indicating the list of activity related to the subject tender as per National Industrial Classification -2008 mentioned in table below only shall become eligible for exemption from payment of tender fee/EMD. Such bidder shall also upload the scanned copy of valid& relevant certificate on (n) procure website along with 'Bid Securing Declaration Form'(Form No 01) in in quotation failing which the bid shall be considered non-responsive. It may be noted that exemption certificate issued by any other authority will not be entertained.
