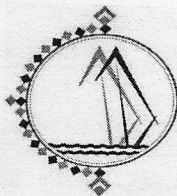

Brief Scope of Work for Consultant

Scope of Work:

2. Preparation of conceptual and detailed architectural designs including plans, elevations, sections, and 3D views.
3. Ensure all designs are in compliance with local by-laws, NBC (National Building Code), and relevant regulations.
4. Development of detailed interior and exterior layouts.
5. Design integration for all buildings and infrastructure for aesthetic appeal and functionality.
6. Detailed technical specifications for all proposed works & materials.
7. The Consultant shall design the following internal and external services such as water supply lines, drainage lines and Firefighting system.
8. Furniture layouts and designs with interior lighting schemes and furnishing details.
