**Sub:- Filling up the post of Sr. Dy. Chief Medical Officer on Deputation basis in Deendayal Port Authority**

Applications are invited for filling up the post of Senior Deputy Chief Medical Officer in the scale of pay of Rs.80000-220000 (IDA pattern) on deputation basis for a period of 03 (three) years, which is extendable to 04 (four) years (In exceptional circumstances, this can be extended to five years by the Competent Authority) from the officers of the Govt. / Semi Govt. / PSUs or Autonomous Bodies.

**Eligibility** : - Officers holding analogous posts or holding posts of Dy. Chief Medical Officer (Specialist) and equivalent Specialist posts in the scale of pay of Rs.13000-18250 (Revised scale of pay of Rs. 60000-180000 - IDA pattern) in a Medical Deptt. In a Govt. / Semi Govt. / PSUs or Autonomous Bodies with 3 years' service in the grade will be eligible. The Selection is by merit for which the bench mark in overall grading in the ACR will not be below "Very good".

**Required Educational Qualification** :-

- (i) MBBS degree from a recognized university
- (ii) A postgraduate medical Degree or postgraduate medical Diploma in the specified specialty from a recognized University

**How to apply** :-

A) The applicants are requested to apply online through the link available on Deendayal Port Authority's website [www.deendayalport.gov.in](http://www.deendayalport.gov.in) under Recruitment Section. The applicant has to fill the Application Form available therein. Online link will be opened till **15/01/2026** only.

- i) Attested copies of APARs/ACRs of the applicants for the last 5 years duly attested by officer not below the rank of Dy. HoD / Group –A Officer on each page. If APARs / ACRs for a particular year during the last 5 years is not available, "No Report Certificate" may be furnished along with APARs / ACRs of the preceding years.
- ii) Attested copies of certificate(s) and proof of age/educational qualification present and past work experience in the respective post and pay scale.
- iii) No-objection certificate from respective office of Govt. / Semi Govt. / PSUs or Autonomous Bodies.
- iv) An undertaking of the applicant not to withdraw, if selected.
- v) Certificate to be given by Head of Office of the applicant (**Annexure – II**).
- vi) Vigilance / Administrative clearance from respective officer of Central Government/ State Govt./ PSUs / Autonomous Bodies along with details, if any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application.
