EXPRESSION OF INTEREST

Sub: Hiring of 2 nos. Mooring Boats with crew for a period of 5 years at Kandla.

Deendayal Port Authority is a seaport in Kutch District of Gujarat state in western India, near the city of Gandhidham. It is one of major ports and is located in the Gulf of Kutch on the northwestern coast of India over 430 nautical miles northnorthwest of the Port of Mumbai (Bombay).

DPA is interested in Hiring of 2 nos. Mooring Boats with crew for a period of 5 years at Kandla capable of operating in all weather conditions. The boats are required to be manned as per rules approved by Statutory Authority.

Specifications and operating conditions of the boats / craft shall be in accordance to Annexure -1 attached herewith.

The boats shall be utilized on 24 hrs duty or round the clock basis at Oil Jetties. Hire period of boats shall be for 5 (five) years. Fuel and water shall be supplied free of cost by DPA.

SPECIFICATIONS AND CONDITIONS

1.1. SCOPE OF TENDER

1.1.1. MOORING BOATS:

- 1.1.1.1 The contract involves hiring of 02 nos. Mooring Boats with crew as per broad specifications listed hereafter for a period of five years, only.
- 1.1.1.2. Fuel/HSD & water will be supplied by DPA free of cost.
- 1.1.1.3. The boats should be capable of working in all weather conditions at Kandla.
- 1.1.1.4. The Mooring Boats will be on duty for 24 hrs. a day.
- 1.1.1.5. The Mooring Boats will comply with all lawful instructions from the Deputy Conservator of the Port or any other officer duly authorized by him.
- 1.1.1.6. All maintenance costs including spare parts, labour, material and consumables will be to owners account.
- 1.1.1.7. Repairs, Survey and other requirements to keep the boats operational will be to owners account.
- 1.1.1.8. The contract will commence and terminate at the Port of Deendayal.
- 1.1.1.9. On the date of commencement of contract, the Mooring Boats shall be sturdy, strong and watertight and shall have completed all the necessary surveys and have valid certificates for the same.
- 1.1.1.10. The Mooring Boats shall be liable to light and buoyage dues but will be exempted from charges payable to DPA.

1.1.2. SPECIFICATIONS - MOORING BOATS:

- 1.1.2.1. The type of steady/sustained Mooring Boats should be single screw with conventional propeller system.
- 1.1.2.2. The Mooring Boats under contract presently may be offered with precondition that the tenderer shall offer the Mooring Boats for Port operation within 4 months from the date of issue of LOA.
- 1.1.2.3. The main engine of the Mooring Boats should be of water cooled type Fuel efficient Inboard Marine Diesel Engine with suitable reputed make gear box to operate the boat with both forward and reverse directions. Mechanism to operate the engine from deck to handle the vessel by the Operator.
- 1.1.2.4. Any other specifications as per annexure A.

1.1.3. MAINTENANCE AND OPERATION

- 1.1.3.1. The operator shall maintain the Mooring Boats, machinery appurtenances and adequate spare parts for maintaining efficient operating condition and in-accordance with good commercial maintenance practice and they shall keep the vessels with valid survey certificate of regulatory authority and with other required certificates in force at all times.
- 1.1.3.2. Each boat shall be manned as per SMD or COS.

The specifications of the Mooring Boats for which tendering is made shall be descriptive in nature with all technical particulars without any ambiguity.

- **1.2.** MANNING AS PER STATUTORY REQUIREMENT: The Mooring Boats should have a set of competent and qualified Crew, as required by statutory regulations and as per SMD of registering authority. When crew is employed initially, it shall be done with the consent of Dy. Conservator of Deendayal Port Authority and any change afterwards if required, shall be carried out with the prior approval of Dy. Conservator or his authorized representative only.
 - 1.2.1. The contractor has to permanently station his representative for liaising with the port authorities or other various departments for any official work of the contractor. If the Port has a reason to be dissatisfied with the conduct or efficiency of the Master or any crew, the Operator on receiving particulars of the complaint, promptly investigate the matter and if necessary shall make a change as found necessary. However, the

Port shall have the right to demand the change of any Master or other crew.

1.2.2. Insurance: The insurance for the tugs and manpower deployed for the port operation shall be arrange by the contractor.
