Terms and condition

Name of the work: Continual improvement of ISO 14001:2015 Environmental Management System of Deendayal Port Authority for the period of two years

- 1. The work shall be carrying out for 2 (Two) years as per work order.
- 2. The rates quoted must be inclusive of all taxes and levies (Excluding GST) No, claims of contractor shall be entertained on account of any other taxes levied by central/state government or any authorities paid by him
- 3. The rates should be quoted in figures and words both, failing which the Quotation will be considered as non-responsive and be liable to discharge.
- 4. Proportionate payment will be made by RTGS mode after completion of each task as per the price bid.
- 5. XEN (EMC) reserves the right to cancel the quotation without assigning any reasons and also increase/ decrease the quantum of work.
- 6. Income-tax and surcharge as applicable will be deducted from the bill while making payment to the contractor for carrying out the work & only net amount shall be paid to the contractor
- 7. The GST Registration No. & Income-tax PAN No, should invariably be mentioned in the bid Quotation, failing which the bid / Quotation will be considered as non responsive and be liable to discharge.

- 13.Quotationers shall have minimum 07 years' experience in management consultancy field along with company registration proof and needs to submit copy of experience certificate/completion certificate of the organization/agency.

- 19. The work is to be carried out at Kandla, Gandhidham & Vadinar area.
- 20. The rate is inclusive of all taxes and related expenses but exclusive of the GST. The contractor shall quote prevailing GST rate separately which shall be reimbursed by DPA after necessary compliance as per Goods and Service Tax Act 2017. All other duties taxes, cess, if any applicable shall be borne by the contractor.
