

In continuation to this office Circular No. Traffic/Traffic/2334/FertilizerStorage/2024/312 Dated 05.05.2025 on the above subject, it has now been decided that during the span of period from 01/01/2026 to 30/06/2026, storage of imported fertilizers at covered godown will be allowed on rental terms for the first 90 days and thereafter, applicable demurrage will be levied as per SOR on the remaining cargo.

All Port Users / Trade Associations are requested to take note of the above. The other terms and conditions contained in the Storage Policy and its enclosures Circulated on 30/09/2021, remains un-changed.
