In exercise of the powers conferred by Sub-Section (1) of Section 27 of the Major Port Authorities Act, 2021 and as per Clause 4.7 of Tariff Policy for Major Port Authorities 2021, the Board of Deendayal Port Authority has approved the proposal as under which has been notified in the Gujarat Government Gazette Extraordinary on 5th February 2026 vide Gazette Extra No.46.

1. Continuance of the existing Scale of Rate of DPA for a period of 1 more year i.e. till 19.01.2027 and reviews the same next year.

2. Transshipment Charges for all types of cargo for transfer from vessel to vessel at Vadinar under schedule of Wharfage Charges of Chapter-III "Cargo Related Charges" stand amended as under:-

"In case of Transshipment of all types cargo at Vadinar transshipment charges of Rs.14.10 per MT shall be levied w.e.f 20.08.2025"
