Brief Conditions:

1. The rate to be quoted without GST. The GST as applicable would be paid extra and income tax shall be deducted as applicable.
2. A small ambulance i.e. brand new model 2026 **Maruti Eeco** is required at liquid cargo jetty round the clock or any other location specified by Fire Officer for emergency purpose.
3. The contractor shall provide one fully equipped road ambulance in excellent mechanical condition with driver with valid registration certificate, insurance, fitness certificate, pollution certificate and all statutory permits.
4. The Ambulance shall be available on a 24 x 7 basis, 365 days a year including Sundays and public holidays.
5. Commencement of contract: The successful bidder shall commence the contract within 02 months from the date of issue of Letter of Intent.
6. Contract Period: The contract period is for 03 years from the date of deployment of required Ambulance as per stipulated time, to be extendable for a further period of one year.
7. Contractor shall provide driver having valid LMV transport license.
8. Petrol charges extra @8 kms per liter, on actual running basis. Petrol rates as per

actual market rate basis at the time of running.

9. The contractor has to maintain the vehicle at his own cost during the contract period.

10. All Labour Rules & Regulations has to be followed.

11. Petrol charges extra @8 kms per liter, on actual running basis. Petrol rates as per actual market rate basis at the time of running.

12. Ambulance should be available round the clock with Manpower.

13. The Ambulance will comply with all lawful instructions from the Dy. Conservator of the Port or any other authorized Officer of Port.
